## DIRECTIONS for ProstaPhase USE And Participant Instructions

## DAILY:

At the beginning of the Study/Trial, you will receive 2 bottles of *ProstaPhase* (PP) product in a sealed 120 Veggie capsule bottle, which is a 40-day supply. Every 40 days you may acquire more product until the end of the Study/Trial. (see trial parameters as to how to replenish your supply).

## Take 3 ProstaPhase capsules 2X daily.

The most important consideration in taking *ProstaPhase* is to use it daily and consistently.

You should take *ProstaPhase* about 2-3 hours away from food for best results. Morning and evening are the best times to take *ProstaPhase* to balance its benefits over a 24-hour period.
